Dawn ANZAC Chorus at Old Taipa House Amphitheatre by Sir Billy Chan

It was 5:15 am, just before the break of dawn. Without a soul in sight, we were enjoying the peace and tranquillity at the beautiful Old Taipa Village. We were walking on old cobblestone pavements towards the Old Lady of Carmel Chapel on the top of the hill overlooking the lake. This lovely area is truly a hidden gem of Macau.

AustCham members and friends were gathering to salute the Australia and New Zealand commemoration of troops lost in World War I and World War II, called 'ANZAC Day'. AustCham has been organising our pre-dawn ANZAC service for a few years now. The timing of the service is associated with the first landing on Gallipoli at dawn on 25th April 1915. It is important for our Australian and New Zealand communities to honour our fallen soldiers who served and sacrificed their lives.

It is sad to say, these losses of life also illustrate how human minds are not always together. War has changed our lives in terrible ways. Many are left with the scars of chaos, grieving because of constant human conflicts.

Despite this, we do not have a Cenotaph here in Macau. Instead, we lay wreaths at flag poles for members of veterans, ex-service personnel and many families. We pay tribute in solemn service.

memorial wreaths and poppies. They read out beautiful ANZAC poems and the Ode together with our AustCham secretary Sharon Warren, and our New Zealand friend Elizabeth Lycette and Grant Bowie. The program was a meaningful blend of respecting the past and the lasting effects on us from war and conflict-- which is

This year, two amazing Australian high school students, Sienna and Caitlyn, laid our

even happening in Europe today in 2022. Great changes globally have been made since the two World Wars. Boundaries seem well defined, but many brave souls are still defending our freedom abroad today.

"The Last Post" and the haunting melody of "Reveille" took on special meaning for our Trumpeter Dave this morning. The sound of the trumpet rippled over the misty lake, conjuring up images of a military disaster more than a 100 years ago. The shared heritage of our two nations shows that ANZAC has always been the part of culture of Australians and New Zealanders. Both national anthems were sung beautifully at the Taipa amphitheatre by the lake along with the lovely sound of the morning birds chirping and tweeting – the ANZAC Dawn Chorus.

I shed the tears when Thomas Griffiths sang the last verse of "And the Band Played Waltzing Matilda". This ballad is about a young Australian soldier who lost his legs during the cruel battle. The lyrics of painful imageries of the devastation at the beach of Gallipoli still resonate now as today despite many of the younger generation becoming apathetic to the veterans and their noble causes.

While we were enjoying a cuppa, passing around some ANZAC biscuits and Lamington cakes, we chatted with ex Sydney resident Stephen Berry, our trumpeter Dave and an Australian trained Australian Chinese doctor, Gabriel Li, we spoke about some of these forgotten heroes when they fought the war some more 90 years ago in Fromelles, France. More than 23,000 Australian soldiers' bodies were never recovered. Mass graves that were later found are now covered with grass in a nearby potatoes farms and woods.

Today, as with in past years, we share stories that very few Aussies were ever told of the 46 Chinese Australian soldiers who died in Northern France and some in Gallipoli too. Many Chinese 'diggers' were buried with unmarked graves in the cemeteries of northern France. These details are often lost.

These amazing servicemen should get some recognition. They deserve to be named for building bridges with the mainstream of Australia today. If we look at what has been happening for the past 100 years about wars and human nature, we may never find the answers as to why we as a species tend to wage wars as a fact of life in our survival.

Humans are capable to fight and sometimes kill. We have the capacity to make war if our ideologies cannot find compromise or peace if we can generate consensus. This is why we must continue to listen to one another for pathways for peace.

GBA Series by Macau Business

Greater Bay Area surpasses 12 trillion yuan GDP mark in 2021

In 2021, the Guangdong-Hong Kong-Macao Greater Bay Area's GDP stood at 12.6 trillion RMB, an increase of 2.4 trillion RMB higher than that in 2017.

Now there are 25 enterprises in the GBA listed among the Fortune Global 500, growing by 8 compared to that in 2017. Besides, there are over 60,000 high-tech enterprises in Guangdong, mostly located within the Greater Bay Area, over 20,000 more than that in 2017.

This information is according to Zheng Renhao, director-general of Guangdong's Development and Reform Commission at a press conference about GBA's development and Shenzhen as a pilot demonstration area of socialism with Chinese characteristics.

In terms of technological innovation, 5 major science and technology infrastructures have been planned for the Greater Bay Area during the 14th Five-Year Plan period (2021-2025), ranking first in China. Now the GBA is home to 10 provincial laboratories and 20 laboratories jointly set up by the three regions.

The number of foreign talents in Guangdong accounts for 20% of the national total and the province's research and development personnel has exceeded 1.1 million.
